# Rural hospitals taking losses during shutdown

The future of rural hospitals was discussed during the weekly Staples Chamber of Commerce

online meeting April 15.

Lakewood Health
System President and CEO
Tim Rice said they are
looking at about a 75 percent reduction in activity,
which projects to a loss of
about \$12 million by July,
when they hope things will
start to get back to normal.
Rice said they got a government payment of \$1.1
million, but that will only
cover about one week of

costs during the shutdown.
One new proposal is for smaller hospitals like Staples to refer COVID-19 patients to larger facilities like St. Cloud. In return, the larger hospitals would send non-COVID patients to Lakewood. Rice said there was some concern that the return business might not match what they could send out. Rice said

the same situation and he was concerned "we may lose rural healthcare," said Rice.

"It is important to do the right thing now to protect our community and our patients," said Rice.

U.S. Representative Collin Peterson said his caucus in Washington, D.C. understands the rural situation. He said they are supporting more money for rural rural hospitals, but that is part of what is holding up the next round of stimulus money. He said they realize that critical access hospitals might not make it through the COVID-19 shutdown.

#### Economic development

Peterson expressed concern about the amount of the stimulus money compared to the national deficit. He said "We were at 70 percent GDP (gross domestic product) in borrowed money, now we are at 100

## **Motley City Council** accepts 2019 audit during call-in conference

Mayor Al Yoder was the lone member seated at the Motley City Council's table April 14, to chair their regular monthly meeting. The rest of the members attended by way of phone.

It's the first time in history the council's had to meet in this fashion, Mayor Yoder said of the call-in conference, going on to note that this was due to the coronavirus pandemic and protective measures that were in place.

Council members who participated via phone included Jace Carlson, Pat O'Regan, Amy Hutchison and Steve Johnson.

Others physically present at the meeting were the city's department heads: Fire Chief Brad Olson, Police Chief Jason Borash, City Clerk/Treasurer Curt Bryniarski, and Public Works Director Bruce Brotherton. Social distancing was observed.

On the agenda was the Annual Audit of 2019 Financial Statements, as prepared by Jon Archer of Schlenner Wenner & Company, certified public accountants from Little

Usually, Archer would be there in person to go over the report with the council, prior to their accepting it. "This is an unusual circumstance, Mayor Yoder noted, adding that he was happy to base his decision on the summary Archer had sent to them. How would the council feel about that? Or, did they want to wait until Archer could be there in person?

A short discussion indicated that they had all reviewed the summary and in the end, they voted unanimously to accept the 2019 audit report.

In his summary of Motley's financial highlights in 2019, Archer noted that revenues in the general

fund exceeded the budget by \$43,608, primarily due to interest earnings, fines and forfeitures. Expenditures in the general fund were \$40,021 less than were budgeted, with the greatest savings being administrative wages, police costs and maintenance expenditures.

According to Archer's report, the city's water enterprise fund showed an operating income loss of \$120,099. The sewer enterprise fund, however, showed an increase in the net position of \$33,818.

• HEARD from Cheryal Hills from NCEDA (North Central Economic Development Association)/Region 5, in regard to a revolving loan (the funds had been transferred from the city to NCEDA/Region 5 last year). Hills reported that they were able to loan out the entire amount, \$177,902. The funds were loaned to Belltech Machine Inc., a CNC machining shop south of Motley on Hwy 10.

• HEARD from George Minerich, Wellhead Protection Planner with the MN Department of Health, during the public hearing. No one from the public joined the call-in confer-

• APPROVED a request from Fire Chief Olson that the Motley Fire Department apply for a federal grant with funds ear-marked to be used for new SCBAs (Self-Contained Breathing Appara-

• HEARD from Police Chief Borash that calls were down due to COVID-19. There were 86 calls in March and he anticipated there would be even less in April.

• DISCUSSED the city wide cleanup scheduled for Saturday, May 16, 7:45 10:45 a.m. and decided to keep it as planned. Those working at it will wear gloves and masks, with curb-side pickup offered.

• DISCUSSED the city's nuisance list and approved sending friendly reminder letters to those with items that could be disposed of during the city wide

• APPROVED a request from Brotherton, Public Works Director, to pay \$2,780 to WW Goetsch for pump repairs and parts.

• LEARNED the Spring Firearm Safety Class, taught by Bob Koenig, has been cancelled.

• APPROVED transferring Northwind Grocery's tobacco license to Kari and Tvler Ehrmantraut of The BBQ Smokehouse Plus.

• APPROVED a resolution accepting donations to the city, earmarked for the fire department's truck

• DISCUSSED on-sale liquor license renewals and approved COVID-19 relief options, allowing establishments to pay only for the months they are

 APPROVED waiving penalties on utility bills for April and possibly May due to COVID-19.

• LEARNED from Bryniarski that with city hall being closed to the public at this time, the drop box outside has been working

• HEARD from council member Johnson during the council forum, who expressed his thanks to all first responders (including law enforcement and fire fighters) who have been out working during the coronavirus pandemic. He urged them to be careful.

 Dock installation and other lake services

 Boat and off-highway vehicle sales and repair, by appointment only

Campgrounds and dispersed camping, outdoor recreational equipment retail stores, recreational equipment rental, charter boats, launches and guided fishing remain closed.

Minnesotans should continue to take part in outdoor activities close to their primary residence. Staying home helps protect Minnesotans from spreading COVID-19 and  $\bar{limits}$ pressure on rural medical facilities and essential supplies.





## **Community** center coping with shutdown

The Staples City Council discussed the future of the Staples Community Center at their April 14 meeting.

City Administrator Jerel Nelsen said the center will remain closed until May 4 or until the Minnesota stay-at-home order ends. Some communities are closing aquatic facilities for the summer because of the COVID-19 virus, but Nelsen said they will continue to monitor the situation and see what the recommendations are

The school's elimination of the girls swimming program will cause further budget changes, Nelsen said. Different programming, along with switching over to a paid entry system could help make up the lost revenue, said Nelsen.

The community center roof is currently under

construction. Nelsen said the insulation on the roof was saturated with water, so there should be an energy savings when new insulation is in place.

### **Wadena County** approves tax waiver

The Wadena County Board of Commissioners voted to approve a property tax hardship penalty waiver process due to COVID-19 for the 2020 tax year. The board voted unanimously in favor of the waiver at the Commissioners meeting held April 14. The goal is to assist Wadena County taxpayer hardships related to the COVID-19 pandemic. Wadena County leaders agreed that there is a need to provide relief to individual taxpayers experiencing layoffs and small businesses that were ordered to close.

Residents and business owners will have to apply no later than the end of business day Thursday, April 30, 2020 to have their late fee penalties waived for properties. This will extend the first half property taxes from the current due date of Friday, May 15, 2020 to Wednesday, July 15, 2020. Taxpayers can print out a waiver application from the Wadena County website or they can contact the Auditor/Treasurer's office for one to be mailed.

percent GDP. Thats getting into dangerous territory."

Peterson said he would like to see how the first round of stimulus funding plays out before going into

another round. Agriculture is another area taking a big hit, said Peterson. He said farmers are dumping milk and euthanizing hogs because the processing plants are closing due to workers infected with COVID-19. He said the state could lose 30 percent of the dairy industry and up to 30 percent of the hog industry because of this crisis.

Peterson's Economic Development Officer Jacki Anderson also took part in the meeting and said every business should sign up for the stimulus money programs, even though some of the funds have reached their limit and are closed. But signing up now will put businesses in position for the next round of fund-

The group said the best way to apply for the stimulus money is to go through a local bank that is in the program or contact area economic development professionals. For this area that includes:



Delays in getting care may be harmful to you, which is why your provider will work with you to ensure care is provided if needed. The stay-at-home order has allowed us to better prepare, obtain needed supplies and equipment, and ensure we can still provide the medical care you may need now.

Some appointments can now be done via telehealth or virtual visit formats, such as Zoom. We have designated separate entrances for sick and well patients. Just as the soil, water, and air around us recovers from some of its poisons when we cease our frantic consumption, perhaps we humans, especially those with the privilege of slowing down, will accept the challenge to renew and liberate ourselves as well. This juncture provides an opening to rethink our values and behaviors, to recreate societies that reflect altruism and peace. Many whose lives are comfortable are now discovering how to live with a lot less, and as we diminish our greed, we reduce one of the major causes of war.

Might we now give up on the illusion that we are rugged individuals and proclaim our interconnectedness? We all crave contact, which we currently attain in dystopian fashion on Zoom. In being present for each other, even electronically, we strengthen our common humanity and social solidarity. We find ways to nurture and weave our precious human web, to remember that our human needs are universal, and that our generosity is a gift that ripples out and reproduces itself. As we engage locally, we extend our concern to those millions of us who are vulnerable, perhaps experiencing increased economic hardship, political repression, the scourge of racism, the pain of exclusion, or health difficulties.

The climate crisis, appalling inequality, the destruction of our earthly home and its flora and fauna, are all powerful evidence that our ways of organizing society are dangerously outmoded. Social change emerges slowly and invisibly, yet the new is always fermenting within the old. Eventually the old ways fracture, and new realities will burst forth. Our minds hurdened by the fear and endless battles of our politics, can take us to negative images of increased authoritarianism, militarism, xenophobia, and injustice. Many will be pushing for that kind of social order, and we have to organize mightily against their demands, beginning now. But we do

not serve ourselves or our society by focusing on our fears. Focus instead on what your awakened and discerning self can see and do. This planet-wide virus, tragic as it is, has the potential to galvanize multitudes. Once awake, there is no returning to delusions like walls, borders, hatreds, or an us-them mentality. Once conscious. we are all "us."

We are each citizens of the community of life and everything we do matters in the universe. Our visions and actions are the building blocks of the community and the world we deeply wish for. We prepare for its arrival as we make the most of this potentially transformative moment



ARTICLE IV. Level III **Predatory Offenders** Sec. 20-80 Findings

and Intent. Repeat predatory offenders pose a serious threat to public safety. Individuals designated by the Department of Corrections as Level III offenders typically have a significant criminal history and have a high risk of re-offense. Most predatory offenders commit numerous offenses, have many more victims than are ever reported, and are prosecuted for only a fraction of their crimes. This makes the cost of predatory offender victimization to society at large, while incalculable, unmistakably

It is the intent of this Section to serve the City's compelling interest to promote, protect and improve the health, safety and welfare of Staples citizens by mitigating the concentration of Level III offenders as intended by Minnesota Statute 244.052, by requiring physical separation between the permanent and/or temporary residences of Level III predatory offenders.

Sec. 20-81 Definitions.

The following words, terms and phrases, when used in this Section of the Staples City Code, shall have the meanings ascribed to them in the following definitions, except where the context clearly indicates a different mean-

Designated predatory offender. Any person who has been categorized as a Level III predatory offender under Minnesota Statutes Section 244.052, a successor statute, or a similar statute from another state in which that person's risk assessment indicates a high risk of re-offense;

Permanent residence. A place where a person abides, lodges, or resides for 14 or more consecutive

Temporary residence. A place where a person abides, lodges, or resides for a period of 14 or more days in the aggregate during any calendar year and which is not the person's permanent address, or a place where the person routinely abides, lodges, or resides for a period of four or more consecutive or non-consecutive days in any month and which is not the person's permanent residence.

Sec. 20-82 Predatory offenders prohibition: penalties: exceptions.

(a) Prohibited location of residence. It is unlawful for any designated Level III predatory offender to

establish a permanent residence or temporary residence within 1,000 feet of the permanent or temporary residence of any other designated Level III predatory offender.

(b) Measurement of distance. For purposes of determining the minimum distance of separation, the requirement shall be measured by following a straight line from the outer property line of the permanent residence or temporary residence to the nearest outer property line of the permanent residence or temporary residence of any other designated Level III predatory offender.

(c) Penalties. A person who violates this Section shall be punished by a fine of an amount not exceeding that set in accordance with Section 115 of this Code or confinement for a term not exceeding 90 days, or by both such fine and confinement. Each day a person maintains a residence in violation of this Ordinance constitutes a separate violation. Violations shall be reported to the Minnesota Department of Corrections and/or the Minnesota Department of Public Safety.

(d) Exceptions. A designated predatory offender residing within a prohibited area as described in Section 20.82 does not commit a violation of this Section if any of the following apply:

(1) The person established the permanent residence or temporary residence and reported and registered the residence pursuant to Minnesota Statutes Sections 243.166 and 243.167, or a successor statute, prior to the effective date of this Ordinance.

(2) The person was a minor when he/she committed the offense and was not convicted as an adult;

(3) The person is a

(4) The residence is also the primary residence of the person's parents, grandparents, siblings or spouse;

(5) The residence is a property purchased, leased, or contracted for and licensed by the Minnesota Department of Corrections prior to the effective date of this Ordinance.

Sec. 20-83 Severabil-

The provisions of this Ordinance are severable, and if any provision of this Ordinance, or application of any provision of this Ordinance due to any circumstance, is held invalid, the application of such provision to other circumstances, and the remainder of this Ordinance shall not be affected thereby.

#### CITY OF STAPLES ORDINANCE NO. 528 **CHANGING DUE DATE FOR UTILITY BILLS**

AN ORDINANCE to change the due date for utility bills from the 10th to the 15th.

Sec. 32-36. - Billing, payment and past due bills.

All municipal utilities shall be billed monthly and a utilities statement or statements shall be mailed to each consumer each month. All utilities charges shall be past due and considered delinquent if they are unpaid at the close of business on the fifteenth day following such billing, provided, that if the fifteenth day shall fall on a Saturday, Sunday or legal holiday, the time shall be extended to the close of business on the next succeeding day on which business is normally transacted. A penalty of ten percent shall be added to and become part of all past due utility bills.

(Prior Code, § 4.2.01)

Sec. 32-37. - Delin-

quent utility bills. Charges for utility service shall be due on the monthly due date as specified by the city and shall be delinquent fifteen days thereafter. The city shall endeavor to collect delinquent accounts promptly. In any case, where satisfactory arrangements for payment have not been made, the utilities department may discontinue service to the delinquent customer by shutting off the water at the stop box and/or electricity at the meter connection box. When utilities to any premises have been disconnected, service shall not be restored to the same consumer except upon payment of all delinquent bills and a reconnection fee. The city clerk shall prepare an assessment roll on delinquent accounts as of September 1 of each year providing for assessment for the delinquent amounts against the respective properties served; provided, however, that this assessment procedure shall not be applicable in situations in which the consumer listed on the city records is only a tenant (lessee) and not the owner of the property. The assessment roll shall be delivered to the council for adoption on or before October 1 of each year for certification to the county auditor for collection along with taxes the following year. When the assessment is certified to the county auditor for collection, the amount is no longer considered delin-

quent. (Prior Code, § 4.2.02)

### Inspired by local people, events


Fuhrman had posted a number of sports stories at his blog. As his fan base grew and the count of entries reached 200-plus, Fuhrman decided to turn his blog into a book, sharing his favorite entries. In addition to some humorous anecdotes, Fuhrman noted there are some serious chapters as well.

The angst of watching his favorite sports teams lose is something Fuhrman experienced early on. It's not included in his book, but Fuhrman said he remembers watching Staples-Motley lose the state basketball championship game to Minneapolis North in 1995. "I was at my grandpa's house in Miltona," he recalled of that painful day for Cardinals

## TWEC approves new headquarters building

Todd-Wadena Electric Cooperative (TWEC) Board of Directors unanimously voted to construct a new headquarters building at their board meeting held March 26, 2020. TWEC has operated from its current facility since it was constructed in 1949, with an office addition built in the

The decision comes in response to intense study and planning with appropriate experts to evaluate TWEC's needs and possible solutions to determine the state of the building, which has served the cooperative for 71 years. The evaluation examined the building's structure, sustainability, building needs, building inefficiencies and

recurrent flooding issues. The current facility offers little insulation, no ventilation and an inefficient HVAC system. The

square footage of the facil-

ity is inefficient for office workflow. "As our current headquarters have served us well for the last 71 years, the board realizes it is cost prohibitive to carry us for the next 71 years," said Miles Kuschel, TWEC Board Chair.

The Board of Directors are working with Contegrity Group, a construction management company based out of Little Falls. The architects have developed designs and specifications based on input from TWEC. The final bids selected came to a total price of just over \$2.7 million, which was below the cooperative's estimated \$3 million project cost. The project will not affect members' rates.

"This decision has been given a vast amount of thought and due process over the years while taking into consideration the needs of our members and

staff," said Kuschel.

The new headquarters will boast hands-on displays for members to learn about energy efficiency, rebates and overall ways to interact with the cooperative. A small conference room will also be available in a private and comfortable setting where members can meet with TWEC

Todd-Wadena Electric Cooperative (TWEC) is a not-for profit distribution cooperative that is owned and controlled by the members they serve. TWEC is located in Wadena, has 8,900 member services in place with approximately 2,250 miles of line. TWEC's service territory includes a majority of the rural areas of Todd and Wadena counties along with portions of Becker, Cass, Douglas, Hubbard, Ottertail and Morrison counties.
