The forum is scheduled for Wednesday, Oct. 19, at 6:30 p.m., at Sourcewell in Staples.


The format is to have city council candidates answering questions from 6:30-7:30 and school board from 7:30-8:30.



Construction in Leader now underway

Infrastructure improvements are underway in the town of Leader, population seven or so.

Located north of Motley off Hwy 64, Leader will soon have new sidewalks and curbs, along with a road through town which will eventually be paved.

Gary Dauer, who owns businesses in Leader, including the Bear's Den restaurant/bar and the 64 Stop gas station, said the improvements are being made possible, thanks to a Cass County grant.

He wasn't sure what to think when he first heard the county's proposal. Was this really necessary for their tiny town? Dauer said he wondered. However, the county explained to him that as part of the grant, they planned on paving the three miles of County Road 101 leading to Wilderness Park. Leader is situated on the first quarter mile of that road, so why not go ahead and pave that in the process? That would be the time to make other improvements as well, such as putting in sidewalks.

time, Dauer said. He went on to say that at least 300 to 400 people live in Wilderness Park and access to it has been difficult, with the road's current condition.

It's coming along well, Tom Newville, Cass County Project Inspector, said at the site Oct. 6. He noted that excavation is being done by Kern & Tabery, Inc., out of Wadena. The road, which will be wider in the end, has been graded, with pavement planned within a year's time.

Beach Construction, LLC of Brainerd has been contracted to do the concrete work in Leader. Dauer said the county explained to him that the new sidewalks will be a plus to the town, both aesthetically and functionally.

During this time, he will be making improvements to the Bear's Den, too, Dauer said. Plans are in the works to add an outdoor patio, as well as handicapped accessible entrances to both the restaurant and bar. If the project stays on schedule. next summer's visitors to Leader will most likely celebrate these improvements, in addition to cheering loudly at the town's famous pig races.




ters of Jerry and Mary Ann Riewer of Staples.



The Staples World reached out to Olsen, asking that he share some thoughts about this thought-provoking play written by Duncan Macmillan with Jonny Donahoe, as well as the unique opportunity that's been made available to all people in this community.

Dawn Timbs asked me 'how I chose this piece", in a way, this piece chose me. This play sat in my inbox, then on a shelf, then a backpack...and it patiently waited until I was ready. Until I was ready to share and tell this kind of story. I've never done a one person show before, and I wanted to challenge myself. But, more than that, I wanted to share/tell a story in the community I grew up in. I wanted to share a story that, I believe, can change someone's life. Art and Theatre has always been a space of growth, challenge and healing for me. This piece is as close as I've ever been to building that experience for the audience (in real time), as well as for myself. I truly believe stories change lives, stories choose us, and we choose who we share our stories with.

Partnering with Lamplighter, The Lakewood Health System, and the Five Wings Arts Council has made it possible for us to provide this experience free of charge. time will be unique.

This story addresses depression, anxiety, suicide, and it does so through a hope, and open-hearted introspection (and laughter, did I mention it's funny?). Through storytelling we are able share difficult things, we find that we are more connected in our experiences than we may imagine.

This piece is unique because I can't do it without (you), the audience. There is a communal participation that the play requires (I promise, I won't ask you to do much). We will build a list of Every Brilliant Thing, everything worth living for, and we will do it together.

We each have a story. Whether beautiful, ugly, dark, bright, hopeful, sad, or mundane, the thread that binds each of them is that storytelling is deeply personal, vulnerable, open and connective. It is intrinsically human.

I grew up here. I learned

to tell stories here. Some of the most affirming experiences of my career have been here, in this community. As an Artist, I have continued to make it part of my mission to return to my roots and bring my love for theater and education back home. This will mark the sixth show I've produced/ facilitated/participated in as a collaboration with the Lamplighter Community Theater (and sometimes the Wadena Madhatters).

My partner, Sarah (who is also my director/outside eye) and myself will be in town all week leading up to the performances. We will be teaching workshops for high school students, doing special performances for them and you'll see us around the community. I imagine I'll run into a few of you at Stomping Grounds. I hope to see many familiar (and many new) faces in the audience each night.

Bullying in schools

According to the website www.pacer.org/ bullying, 1 out of every 5 students report being bullied. In addition, 41% of students who reported being bullied at school indicated that they think the bullying would happen again.

Of those students who reported being bullied, 13% were made fun of, called names or insulted; 13% were the subject of rumors; 5% were pushed, shoved, tripped or spit on; and 5% were excluded from activities on purpose.

A slightly higher portion of female than of male students report being bullied at school (24% vs. 17%).

Students report that bullying occurred in the following places: the hallway or stairwell at school (43%), inside the classroom (42%), in the cafeteria (27%), outside on school grounds (22%), online or by text (15%), in the bathroom or locker room (12%), and on the school bus (8%).

The reasons for being bullied reported most often by students include physical ap-

pearance, race/ethnicity, gender, disability, religion, and sexual orientation.

Minnesota school districts are required to adopt, implement, review, and revise written policies to prevent and prohibit bullying. These policies must include requirements to notify the parent of the reported target and the parent of the actor engaged in the prohibited conduct. School districts must provide appropriate training for all school personnel to prevent, identity, and respond to prohibited conduct.

Statistics show that bullying prevention programs, like the ones that Hands of Hope Resource Center provide, decrease bullying by up to 25%.

creatively about eliminating war. Here in the United States, we can look to our own history for a way to accomplish that. When Americans decided to transform the confederation of 13 colonies into a federation of states, they agreed to resolve their differences in a court of law rather than on the battlefield. The original 13 states were able to eliminate or transform their militias. With no need any longer to fight one another, they could rely on the rule of law to settle disputes. Although the rule of law is not perfect, it is the best method we have found. And it is preferable to war.

We need a similar transformation at the global level. Why not transform the confederation of nations known as the United Nations into a United Federation of Nations? Under this strengthened UN system, all nations could agree to resolve their differences using the rule of law rather than weapons of destruction. Nations could be required to disarm and to transform their armed forces into peacekeeping forces that would respond to natural disasters and other domestic crises.

To implement this program, we could start by creating a World Parliament at the United Nations to give a voice to the people of the world, rather than just their governments. We also need a world constitution to define a democratic federation of nations with a universal declaration of human rights and the ability to create and enforce world law that outlaws war and nuclear weapons. Furthermore, we will need international courts (such as the International Criminal Court) and international police to arrest those who break the law. Fortunately, much work has been done defining these components over the past 75 vears.

All these components will cost much less than the

Competitiveness OK, until it isn't

As competitive as Americans are, competitiveness is not a uniquely American thing. We see it in the Olympics, and in the periodic world championships held in such sports as skiing, soccer, hockey, and more. In these events we see participants from so many countries that there are some I've barely heard of. The point is, competi-

tiveness - 0 seems to be Inside the an innately Outdoors human

trait.

Some will argue that competitiveness might be what allowed our human species to

survive, Mike Rahn a n d to dominate the planet

we inhabit. Then again, perhaps just as strong an argument could be made that cooperation among early human communities was the golden ticket. Some of us dislike competition. Others thrive on it, and accomplish great and notable things as a result.

Competitiveness can also bring out the worst in us, as evidenced by the recent 'bust" of two anglers for cheating of the most brazen kind in a Great Lakes walleye tournament. Had they gotten away with it, the first prize winnings for these angling partners would have been in the neighborhood of \$20,000, not to mention the recognition and sponsorship perks that typically come with a high-profile tournament victory.

How brazen was their cheating? The would-be winning fish they brought to the weigh-in at the tournament's conclusion had gained weight after being caught. It was weight in the form of lead fishing sinkers, stuffed down the walleyes' gullets. The weights, said to total about eight pounds among the multiple fish, were wrapped in fillets of smaller walleves so that they would not be evident.

The pair were caught when one of the tournament officials - present at the weigh-in - was struck by the contrast between the weight shown on the scale and his visual estimate of their size: "fishy," you might say. Experienced anglers can often closely guesstimate a fish's weight by its appearance, its apparent size. When the scale and appearance seemed a mismatch, the official ordered that the fish be cut open, and the lead weights were found.

Now, instead of cash and accolades, the two anglers will reportedly be banned from competing in future tournaments held by the sponsoring organization. Some of their earlier tournament wins are even said to be under suspicion, though cheating in them would be hard to prove now.

There are certainly other examples of cheating in the world of sporting competition. There has been steroid use by several of baseball's former long-ball hitters, as well as some former Olympic swimmers, blood oxygen enhancement in professional cyclists, even having too much curve in the blade of a professional hockey player's stick. Some violations are egregious, others seem trivial. But all, big or small, are an attempt to gain some kind of advantage over the competition.

For their part, the tournament officials involved in this bust are rightly concerned that incidents like this could negatively affect how other anglers - as well as the general public-view fishing tournaments. The most charitable spin on this incident is to hope that this pair of anglers are ethically-deficient exceptions, and that fair play and honesty prevail more often than not.

That said, the ingredients that can bring out the darker side of human nature are present in many fishing tournaments. When boat-motor-trailer rigs worth \$150,000 are the prizes sometimes at stake, as well as hefty cash prizes, there is incentive to break a rule or two if the opportunity presents itself. If an angler has made fishing and tournament competition his or her career, there is even more pressure to win. That's not to say that tournament "pros" have lost their purer love for angling. But there is clearly potential for mixed motives.

The obvious exceptions are the so-called "club' tournaments, where little more than bragging rights among friends or co-workers—and maybe a modest trophyare the extent of rewards for winning an angling competition.

In fairness to the many who compete in fishing tournaments, or who follow them as fans and aspiring anglers in their own right, we have to remember our legal tradition of "innocent until proven guilty." Assuming dishonesty, "tarring everyone with the same brush" as the saying goes, is neither fair to the honest, nor a positive way to live.

But it's a conversation that would probably not be there if we weren't doing for money what has more traditionally and more widely been done for its recreational value; for love, as it were. We shouldn't forget that "amateur," so the linguists tell us, has as its Latin root "amare," which means "to love."
