NOTICE OF STATE GENERAL ELECTION**

Notice is hereby given that a State General Election will be held on November 5, 2024. The State General Election Ballot will include the offices of U.S. President and Vice President; U.S. Senator, U.S. Representative District 8; State Representative Districts 2B, 5A and 5B, 6A; County Commissioner Districts 2, 3 and 5; Soil and Water District Supervisor Districts 2, 3, and 4; Supreme Court Chief Justice, Associate Justices Seat 5 and 6; Minnesota Court of Appeals Judges Seats 2, 3, 4, 6, 8, 12, and 14; Ninth Judicial District Judges Seats 3, 7, 9, 10, 13, and 24. One Constitutional Amendment Question will be on the ballot Titled-Environmental and Natural Resources Trust Fund Renewal; Shall the Minnesota Constitution be amended to protect drinking water sources and the water quality of lakes, rivers, and streams; conserve wildlife habitat and natural areas; improve air quality; and expand access to parks and trails by extending the transfer of proceeds from the state-operated lottery to the environment and natural resources trust fund, and to dedicate the proceeds for these purposes? The ballot will also include local elections for the following contests within respective jurisdictions:
