# Local barn quilt trail featured statewide

A Creative Investment exhibition, celebrating ten years of Legacy art and impact, opens on April 26, at the Minnesota State

Barn quilts, quilt blocks painted on wood squares, have a rich history as an artistic expression in rural areas throughout the United States. Each handmade quilt tells a story of the quilter and point in

Barn quilts made by art engagement through- friends and local residents in 2016, with funding provided by the Five Wings Art Council. What began in 2016 with seven barn quilts featured on local barns and businesses has grown to encompass 92 barn quilts.

In 2008, Minnesota voters approved the Clean Water, Land and Legacy Amendment to the state's constitution. For a period of 25 years, the amendment will dedicate a pool of funds for clean water, parks and trails, outdoor habitat, and arts and cultural heritage. ## **Boston finisher**

Wade Bendson, of Staples, poses with his finisher's medal after running in the Boston Marathon on April 15. "It was a great experience but the course was way tougher than I thought it would be," said Bendson. And it wasn't just the famously steep "Heartbreak Hill" at mile 20. "The whole 26 miles, there was hardly a spot where there wasn't an uphill or downhill," said Bendson. By the end, "going downhill was just as hard as going uphill, it hurt my legs the most," he said. It was Bendson's third marathon. He ran one in Fargo to see what it would be like, then ran it again to try and qualify for Boston, which limits entrants to 30,000 runners. Bendson said this was his slowest marathon, but he placed in the top 1,594 for his division and 12,844 overall, finishing in three hours 43 minutes.



# Hiring freeze rejected

The Todd County Board of Commissioners discussed and then did not approve a hard hiring freeze that had been suggested by Commissioner Randy Neumann.

Neumann said that since the property valuations have come out, many in his district saw property value increases ranging from \$20,000 to \$105,000. He's been getting a steady stream of calls from constituents who've been telling him they can no longer "afford to live in Todd County."

He felt the county was taxing people right out of the county and felt that implementing a hard hiring freeze through 2020, could provide an answer.

Commissioner Rod Erickson asked what was different about what Neumann was suggesting and what the county already did?

Neumann said that this would tell the department heads there'd be "no new positions.'

"It tells the taxpayers, 'We hear you," said Neumann.

Erickson said he thought having such a strict guideline would limit them if a situation came up and the need for a position arose.

'We already have the option to deny," said Erickson.

Commissioner David Kircher said they already have a form that the department heads have to fill out to justify a hire and where the money will come from before it goes to the finance committee.

"I agree with Rod, we have a process for handling this," said Kircher.

Neumann said he still felt they needed the hard hiring freeze and needed to do more with less.

Commissioner Barb Becker stated that this was another layer of them being able to ask "Do we really need this employee? Do we really want to go down this road?"

Kircher talked about the underlying issue that Todd County citizens had received their valuations in the mail and the county had little control over this as it was based on sales of property. He said he's upset with what the state forces them to do with raising the valuations. Neumann agreed, that's true, but that he'd never seen a jump in valuations this severe. He said that some farmers had been hit with a \$150,000 jump in their property value.

Engineer Loren Fellbaum said that federal funds pay 90 percent of this with a 10 percent county match.

· Granted subdivision request to create a six lot subdivision named Leevilla Townsite, First Addition on Little Swan Lake with conditions recommended by the Planning Commission.

· Approved Sheriff Steve Och as the alternate representative to the Central Minnesota Next Generation 911 committee. Dispatch Supervisor Sarah Booker will remain the primary delegate.

• Approved to hire Nicholas Miller as a full-time jailor effective as of April at a Grade 6, Step 1.

 Sheriff Steve Och has applied for and received a Federal Boating Safety Supplemental Equipment Grant. This grant is in the amount of \$27,513 and will be used to purchase a 2019, 1775 Lund Impact Sport boat with a 115 hp Mercury motor, with Lowrance scan locator and two Onyx Insight auto inflate lifejackets.

It was approved to accept the grant and make the purchase. Och said this will include a trade in of one of the current boats the department has.

Later, during the work session, Todd County Assessor Chris Odden attempted to explain how the valuations were derived based the on previous year's sales and what he's to look at as far as setting the valuations.

#### In other business, the board

• Approved a gambling permit for the St. Mary of Mt. Carmel Church to hold a raffle.

· Approved repurchase of tax forfeited parcels for Edward C. Davids.

• Approved a transfer of funds for the American's with Disabilities Act Transition Plan for the county's Industrial Park project. The expenses have now been finalized for the Industrial Park project and the amount of funds remaining equals \$14,295.80. Later, the board adopted the Todd County ADA Transition Plan as presented.

• Proclaimed April 7-13 as National Crime Victims' Rights Week in Todd County. Hands of Hope General Crime Services Coordinator Barb Dinkel Goodrich said that this year's theme is Honoring Our Past, Creating Hope for the Future.

Proclaimed April as Sexual Assault Awareness Month in Todd County. In 2018, the Hands of Hope Resource Center served 53 victims of sexual assault, 24 of those victims were children under age 18.

According to HOH Sexual Assault Program Advocate Connie Nelson, "These numbers may not seem so staggering, except for the fact that over 70 percent of sexual assaults are never reported to anyone." She shared that many sexual assaults happen within one mile of the victim's home and 80-90 percent of these assaults are committed by someone the victim knows, such as a classmate, friend or relative.

She encouraged citizens to speak up.

"If you see something, say something, or call law enforcement. Don't let this crime continue in our county. One never knows when they, a family member or friend could become the next victim.'

 Approved the bid from Traffic Marking Services for \$229,172.27 for the work of 6" wide ground-in wet reflective epoxy edge lines located on various highways in Todd County. This will cover 38.5 miles. County

 Approved the hiring of Richard Mettler for Behavioral Health Supervisor in the Health Services Unit. Interviews were conducted, with the board approving to promote and hire an internal applicant,

• Employee #848 has been off work for medical reasons off and on since the beginning of October, 2018. This employee ran out of FMLA protected leave on Feb. 11. The required doctor's note has been provided and the union contract states that with board approval this employee can be on medically required leave for up to one year. The board approved a medical unpaid leave of absence for this employee for up to one year.

• The supervisor of Employee #883 requested a one-time six (6) month extension of the employee's probation period to give the employee sufficient time to prove their ability to work effectively for the county. It was approved.

• During the last work session in March it was discussed to make three changes to the Board Protocol policy. These changes are being made for clarification and direction for future board meetings.

The first change is in Section 2, adding the Human Resources Manager as someone who shall be on the Personnel Committee.

The second change is in Section 8, subsection d, adding to the consent agenda, board action forms to approve the hiring of employees and the departure of employees.

The third change is in Section 9, the addition of subsection d. "When a motion is made to table a discussion, item, or topic, a later date shall be set to resume what was tabled and a vote is not required. If a motion is made to table the same discussion, item, or topic again, Robert's Rules of Order will be followed for this procedure. This motion can't interrupt a speaker who has the floor, it must be seconded, it can be debated, it is not amendable and requires a majority vote."

This was approved.

 Tabled action on recruiting and hiring a Planning and Zoning and Soil and Water **Conservation District Division Director** until it's known what the percentages where for the salary/work ratio.

· With the departure of the past Division Director, Loren Miller has been the interim Planning and Zoning Administrator. This has caused Miller to take on extra duties and responsibilities. The Personnel Committee has agreed that a temporary wage increase of three percent should be brought to the board. It was approved and the three percent increase will be backdated to the day Miller started as the interim Planning and Zoning Administrator, on Feb. 11.



# **Teacher recruitment** efforts at Sourcewell


Sourcewell held the first annual Central Minnesota Education Job Fair on April 3 in Staples. The event was to help schools overcome a state-wide teacher shortage, which is especially apparent in Sourcewell's Region 5 area, where there are no teacher colleges in the five county area.

Sourcewell hosted 18 of the 25 Region 5 school districts, schools located in Todd, Wadena, Morrison, Crow Wing and Cass counties.

The City and School District were partners in the construction of the Community Center, including the grant application, land donation, site-work and ultimate repayment of the bonds. Additionally, the School District has been a heavy user and rent paying tenant of the facility since 1974 for school related pro-

gramming. The writer was correct

that the City has been looking for ways to expand the Community Center. These efforts began in 1977. Since that time, there has been no fewer than seven different options considered to provide additional space and meet the demands of the users of the facility. These efforts included participation from the school district, Central Lakes College, Lakewood Health System, Sourcewell and others.

The taxpayers of the City of Staples currently fund the operations and improvements at the Community Center. Interestingly, only 34 percent of the current Community

Center members and 16 percent of the Lap Swim and Aquasize participants are city residents. In addition to members, school utilization, swim lessons and senior activities, there are, on average, well over 1,000 sign-ins per month. The building is heavily utilized by people throughout the region.

Perhaps not every resident of the School District will use the Staples-Motley Activity Center on a regular basis but we are certain that those who do will mirror the geographic area of the school district much closer than the City of Staples.

# Hands free safe driving

Minnesota lawmakers took an important step this month toward improving public safety.

The state legislature approved the "hands-free" bill that bans the use of hand-held cell phones while driving and aims to prevent distracted driving accidents. Minnesota joins 16 other states and Washington, D.C. with similar laws. The change will be become effective August 1, 2019.

The bill requires drivers to be "hands-free," but allows the use of voiceactivated commands in a "hands-free mode" for calls and other functions like GPS navigation and music applications. The law does not apply to drivers in emergency situations. It expands on current Minnesota statutes that ban

#### texting, using e-mail, and browsing social media while driving.

"Many of the families who have been affected by distracted driving, and who have been tirelessly advocating for this law, are the reason we're here today," Governor Walz said while signing the bill last week. "Minnesotans deserve safe roads and this bipartisan bill helps prevent senseless accidents and improves our public safety.'

Distracted drivingrelated crashes in Minnesota have claimed an average of 45 lives each year, according to the Minnesota Department of Public Safety. The number of fatalities resulting from distractions peaked in 2015 at 72 and has dropped since then.

Part of the reason might have been the approval in 2014 by the legislature of a Minnesota's "No Texting" law, which makes its illegal for drivers to read or send texts, e-mails or access the web while the vehicle is in motion or a part of traffic. Texting and driving citations jumped 30 percent from 2017 to 2018 with 9.545 tickets written by law enforcement statewide, according to Minnesota court records. Since 2012, texting citations increased by 459 percent.

Even with the passage of the "hands free" law, drivers can do more. They should avoid eating and drinking while driving and make sure their GPS systems are set up before going into motion. It's also important to secure children in the back seat to avoid needing to look back at them while in motion.

Drivers, especially those with older cars, will need to make preparations for the new law by getting devices that can hold their phones. Better yet, put the phone in the back seat. The calls can wait.

O-O Ask A Trooper

#### **DWI Questions**

**Question**: My ex-husband was pulled over and charged with a DWI. He paid about \$1,000 in fines prior to his court date. In court he was fined another \$400, that's it. He was not ordered to place the "whiskey plates" on his truck. He had a suspended license for a measly 30 days.

My question for you is can this truly be all the regulations placed on a person who is arrested for drunk driving? This sort of thing makes my stomach turn. People are not being held accountable for their actions and are given a slap on the wrist for poor decision making skills. In this day and age, there is no excuse for driving a vehicle under the influence of alcohol.

**Answer**: In my career, I have investigated far too many crashes where someone was seriously injured or killed as a result of a driver's decision to operate a motor vehicle while under the influence.

In Minnesota, it's against the law for a person who is under the influence of alcohol, controlled, or hazardous substances to operate a motor vehicle. The severity of the offense increases depending on impairment level and past DWI convictions.

If convicted of impaired driving, the penalty for a first offense is up to 90 days in jail and/or a \$1,000 fine.

If the driver has prior DWI convictions, the penalties increase to 2-7 years in jail and/or fines of \$3,000-\$14,000.

Refusal to submit to a chemical test may also result in a fine and jail time.

Along with possible fines and jail time, a driver's license will be revoked from 3 months - 4 years. The offender may also lose their license plates and car and their insurance costs will increase.

Minnesota law enforcement officers are trained to identify drivers who are under the influence of alcohol and drugs, and we are committed to taking impaired drivers off the road before they injure or kill themselves and others. If a person chooses to operate a motor vehicle while impaired from alcohol or drugs, they will face consequences.

If a person feels the effects of anything that impairs their ability to operate a motor vehicle safely, they need to make the right choice and not get behind the wheel. They should ride with a sober driver, take a safe, alternative transportation option or stay at their location. The best thing to do is to plan ahead for a sober ride before going out to have a good time.



## **Danculovich reels in seven-foot swordfish**

"What an experience," Tom Danculovich said of fishing off the coast of Cancun, Mexico, and catching a seven-foot swordfish.

The Staples man, 73, said his wife, Diane, encouraged him to take part in a fishing excursion while they were on a recent vacation. He vacillated about it for three hours, but in the end decided to take his wife's advice. "Diane said, 'you've got to do it,'" Danculovich said, adding that he knew it was something he'd probably never get to do again in his lifetime.

He and three other guys set out on the fishing charter at about 11 a.m., Danculovich said, adding that two were from Canada and one from Colorado.

The rollers on the ocean were over six ft. tall, Danculovich said of the waves that day. At the end of the first half hour "we had nothing," he shared, going on to note that two of the crew were on the deck and two were down below sick. "I felt really bad for them," he said.

Danculovich and the other top-side fisherman each had a fishing rod and after about two hours on deck, both of their rods started going crazy. "It seemed like we were fighting (the fish) forever," he said.

Finally, after an exhausting struggle, they both reeled in an enormous

swordfish. Danculovich's fish measured seven ft. in length; and the other guy's was seven ft. two inches.

He knew he wanted the fish to live, so he barely had time to have a photo snapped before throwing it back in the ocean. The captain couldn't believe it, Danculovich said of his decision not to keep his amazing catch. "He's out there swimming," he said of the fish.

The other guy (one of the Canadians) decided to have his fish mounted and shipped to his home, which ended up costing \$1,746. That's a lot of money, Danculovich said. "I got the picture...that's my trophy," he added.

Up until this recent adventure, his fishing excursions have mainly taken place on Midwestern lakes. "We've got a cabin by Alexandria and I do a lot of fishing there during the summer," Danculovich said, adding that in the winter months, he likes to ice fish on a certain lake in the Lincoln area (he's not giving the name, he laughed).

He's collected a number of fishing stories over the vears, including that time 20 years ago when he took second place at a walleye contest on Rush Lake. "I won \$750," Danculovich said. Most likely, his story of catching the swordfish is one of those that will be told and re-told when out fishing with family and friends in years to come. It was quite an experience.



# Minnesota fishing opener destinations

As we head into the waning days of April, our thoughts turn to the fishing opener just weeks away. The ice has left our lakes earlier than anticipated, meaning most of our deep, clear lakes of the north will be ice-free as will the western and southern. shallower lakes. Here are some thoughts on the 2019 Fishing Opener.

1.) Shallow lakes

I've always been a fan of the shallow, farm type lakes of western Minnesota on the fishing opener. These lakes tend to peak in May and usually are well ahead of the deep, northern lakes in water temperatures. The difference can be as big as

20 degrees which is a huge factor in early season walleye success. Lakes such as La Qui Parle, Traverse, Big Stone, Shields and Albert Lea Lake are some of the better choices. Walleye populations are good and the fishing pressure is minimal as compared to the well-known lakes up north. 2.) River systems

No doubt the St. Croix, Snake and Crow Rivers are good May choices but the high water is going to make these river systems pretty unstable. The current alone will make boat control a nightmare and I don't see the water receding anytime soon. This could be a wash out for the river systems at least until early summer. There's also

a ton of debris coming down the rivers which makes for a very dangerous scenario.

3.) Walleye limits

Some major walleye slot limit changes have been made throughout the state of Minnesota. Leech Lake has now been changed to four walleye under 20 inches. The same new slot is also in place on Lake Vermilion, four fish under 20 inches.

Red Lake also follows suit and Lake of the Woods has decreased the sauger limit by two. In my personal opinion, the previous 17 inch slot was very unfair and unrealistic on so many of our lakes. Four walleye is plenty and very fair.


Velma Van Blaricom, 82, of Caldwell, Idaho passed away April 9, 2019.







# Top 10 reasons for not applying for VA compensation

#### By David A Anderson, Wadena County Veteran Services

The Top 10 Reasons Veterans Don't Pursue Benefits.

1. I don't trust the government. Many veterans have indicated that they don't trust their government in matters of confidentiality and privacy, therefore have no interest in pursuing benefits. Veterans from the Vietnam era are particularly sensitive regarding their distrust of the government. Many veterans from that era have indicated that they had a very bad experience while in uniform and feel as though the government isn't really inclined to assist or help them. One veteran said, "The government did me wrong while I was in Vietnam, and I'm sure they'll do me wrong again.'

2. I didn't know I was eligible. Far too many veterans are unaware of their eligibility status. They assume that since they aren't registered to use VA services, they're automatically ineligible for benefits. One veteran said, "I never retired from the military so I always believed I

the "red tape". Many veterans are of the belief that pursuing benefits from the VA is a matter of navigating a very complex and confusing system that involves mounds of documentation. While it may be true that there is a lot of paperwork, most, if not all is handled by a competent VSO or CVSO and not the veteran. The VSO/CVSO is trained to work with the bureaucracy, not the veteran, and takes much the complexity away from the veteran. One veteran said, 'It's just too confusing to get started."

5. I don't know how. While there are many veterans service organizations in existence, many veterans don't understand how these organizations can really help them apply for benefits. Most veterans don't know where to begin. One veteran said, I always thought a VFW was a bar for veterans and they sit around and swap war stories. I never knew they had staff on board that could help me apply for benefits.'

6. I make too much money. Many veterans make over \$100,000 annually, and are receiving compensation for a service-connected disability. A veterans' disability is independent from their income from other sources and isn't a factor in determining eligibility. There are a few millionaire politicians who are service-connected and receive monthly compensation from service-connected disability. One veteran said, "I never applied for benefits because I always believed I made too much money to be eligible for compensation.' 7. I was denied after the war. Many veterans are denied after first applying for benefits, whether a few months after serving in a war zone or vears later. Bottom line, sometimes it takes a few tries to get it right. A veteran said, "I applied for compensation after being diagnosed with PTSD and was quickly denied. I decided it wasn't worth my time to try again."

compensation, while other veterans appear healthy, except for a few nagging conditions and aren't sure if their condition would be considered for compensation. Discussing your issue with a respected and competent VSO is very important. They often know what's potentially eligible for compensation and what isn't, most importantly, how to get your benefits started. Another veteran shared, "I have so many things wrong with me I don't know where to start. If I submit claims for all of my conditions the VA will reject all of them thinking I'm not telling the truth."

9. I can't prove my health problems are related to my time in the military. Finding a good VSO/CVSO is very important in securing disability compensation for a serviceconnected condition. The VSO helps connect the dots for you and some are very innovative in helping veterans find the appropriate proof needed for their claims. Some VSOs "inside connections" that may be able to locate documents needed for proof showing that you are a veteran. A veteran said, "The VA can't find my medical records so I can't prove I was injured

#### **DESCRIPTION OF PROPOSED SCHOOL CONSTRUCTION PROJECT**

Staples-Motley School District, ISD #2170-01, is proposing a two-question bond referendum on May 14, 2019. The first ballot question would authorize \$48,220,000 in bonding authority to finance the conversion of the existing high school to a grade 5-12 facility and improvements to the elementary school which would serve grades Early Childhood (EC)-4 students. The second ballot question would authorize \$10,450,000 in bonding authority to finance an activities center addition to the elementary school.

In addition to the projects proposed in the two question referendum, the school district plans to issue \$3.5 million in long term facilities maintenance bonds to finance deferred maintenance at the elementary school and \$2.5 million in capital facilities bonds to complete other deferred maintenance projects at both school sites.

The district has supplied cost estimates to operate and staff the additional building space and believes existing revenues will be sufficient to fund any operational cost increases associated with the proposed facility additions. In addition, the school board believes the proposed projects are in the best long-term interest of the district.

If the bond referendum is successful and bonds are sold, the debt service on the bonds will be eligible for debt service equalization under Minnesota Statutes, section 123B.53, subdivision 3, if the bond schedule is approved. The amount of debt service equalization aid, if any, the district receives is determined annually and is dependent upon property wealth, student population, and other statutory requirements.

#### **Review and Comment Statement**

Based on the department's analysis of the school district's required documentation and other pertinent information from sources of the Minnesota Department of Education, the Commissioner of Education provides a positive review and comment.






