

City approves lot sale for Casey's store

The Staples City Council approved a purchase agreement for two city-owned lots, between 7th and 8th St. NE, near Hwy 10, to Casey's Retail Company, a convenience store business.

At their July 25 meeting, City Administrator Jerel Nelsen said they have set a closing date for Jan. 31, but they anticipate it being done earlier than that. He said Casey's will have to purchase other lots from landowners and will have to request the alley be vacated, which will require a permit from the city. "There are some hoops to jump through," said



The United States became the first and only nation to use atomic weaponry during wartime when it dropped an atomic bomb on the Japanese city of Hiroshima on Aug. 6, 1945.

aejeatea. The war against Japan in the Pacific, however, continued to rage. President Harry S. Truman, warned by some of his advisers that any attempt to invade Japan would result in horrific American casualties, ordered that the new weapon be used to bring the war to a speedy end. A blast equivalent to the power of 15,000 tons of TNT reduced four square miles of the city to ruins and immediately killed 80,000 people. Tens of thousands more died in the following weeks from wounds and radiation poisoning. Three days later, another bomb was dropped on the city of Nagasaki, killing nearly

40,000 more people. A

few days later, Japan

Long Prairie man charged with murder

rie man accused of using a knife to kill a woman was charged July 31 with second-degree murder.

Jose Raul Herrera-Torres was charged in Todd County District Court and remains in custody on a \$1 million bond, with conditions. The criminal complaint alleges that Herrera-Torres stabbed Dominga Mejia Guerrero, 58, at their home at 451 Todd Street South in Long Prairie on July 27.

Her body was found at about 8 p.m. that night by another person who lived at the residence and called police. Authorities said Guerrero died of apparent knife wounds.

Investigators talked with a neighbor from across the street who reportedly saw Guerrero sitting outside on a step talking on a cell phone at

A 35-year-old Long Prai- about 5:30 p.m. that night. A few minutes later, the neighbor said, Herrera-Torres arrived in his Ford

The witness reported hearing what sounded like glass breaking or something being thrown into a garbage can," along with yelling from inside the

Herrera-Torres didn't go to work the next morning and withdrew cash from his credit union in Cold Spring, according to the complaint.

On Friday morning, the Long Prairie Police Department and the Minnesota Bureau of Criminal Apprehension issued an alert asking for the public's help in locating Herrera-Torres. They received a call from the Long Prairie CentraCare Hospital that

Comprehensive plan survey results listed

The City of Staples is in the process of developing a community vision and comprehensive plan update. Two electronic surveys were available for public input from May 15 through July 26, 2017.

The general community survey included the areas of transportation, housing, economic development, community vision, healthy communities, among other plan elements.

The parks, trails and open space survey studied areas related to community aspirations, accessibility, uses and possible project locations.

Survey respondents noted the top four elements that make for a healthy community as a healthy economy, successful school district, low crime and safe neighborhoods, and access to healthcare.

Participants noted support

- supporting local businesses,
- enhancing the trail network, maintaining the effective
- transportation system and capitalizing on Staples great-
- est assets. A list of themes were also iden-
- tified where change is desired:
- blighted neighborhoods and vacant storefronts,
- expanding housing choices, • improving community collaboration and support,
- revitalizing the downtown, • improving bicycle networks
- and connections and

• addressing growth and development challenges.

A total of 225 responses were received. These responses will form the foundation of the plan, ensuring that the goals and strategies are designed with the community in mind

The project team will continue to analyze the results of the survey, which will form the foundation of goal and policy development efforts. A series of draft goals will be developed by the steering committee with aims of a second visioning session to be held in the fall for further participation and

public comment.

This plan is a long-range guiding document that will help the city in managing growth and development to 2035. It will establish a unified vision of the city's future, directly fed by the guidance of the community.

He recalled the year they tore down the 1920 building and added on the new gymnasium and locker room. During that time they also remodeled what had formerly been a technical college and converted it to what is now the high school.

"Then in 1990, Centennial Auditorium was built. That was another big change here," Bruce said on July 31, his last day working at the high school.

adding that highlights included going on music trips with the high school music department as a chaperone. A 1970 Staples High


School graduate himself, Drone has been loyal to the Cardinals for a long time. Although he had previ-

Two years after that, Mike Cizek hired him to be a part of the custodial staff. Early on, the focus of his job was in custodial maintenance, but in recent years it has been in custodial cleaning.

Custodians keeping it clean at SMHS

There seems to be a misconception that school custodians are taking it easy during the summer months.

"That's actually one of our busiest times...that and basketball season," said Travis Benson who has worked as a full-time custodian at Staples-Motley High School for the past seven years.

As soon as school lets out in May, the custodial staff kicks it into gear to make sure the facility is in tip-top shape before classes resume in the fall.

"Everything cleaned," said fellow-custodian Bea Meech, mentioning desks, chairs and cupboards, all of which get taken out into the hallways so that the classroom floors

The tables are heavy, Benson said, adding that they work together and

also use a cart to move them. They scrape gum from the bottoms of desks, but Benson said they've been finding less gum than in other years. "So, that's good," he said.

There are approximately 34 classrooms at the high school, Meech said. "Plus the athletic end and all of the offices," she added, noting that it takes quite a while to get through every

Once those rooms are finished, the custodians will concentrate on cleaning the hallways. "We do those last," Benson said. "They are all scrubbed twice and then they get two coats of wax."

They're pretty much on schedule, Meech and Benson said. "School starts the day after Labor Day, so we have to be finished by then."

Proposed 2018 health insurance rates released

Minnesotans can now see proposed 2018 rate information submitted by Minnesota insurers to the Minnesota Commerce Department for individual health insurance plans, including those that will be sold through MNsure.

All insurers that currently offer health plans in Minnesota's individual market have filed rate proposals for 2018.

The insurers' rate proposals, which are preliminary and must be reviewed by the Commerce Department, are available on the Commerce website (mn. gov/commerce). Also available are proposed 2018 rates for small group health plans that serve employers with 2-50 employees.

Final 2018 rates will be announced by Oct. 2. The 2018 open enrollment period to buy health insurance begins on Nov. 1 and is scheduled to continue through Dec. 15.

The individual market rate proposals apply only to Minnesotans who directly purchase their own health insurance policies. Most Minnesotans receive coverage from employer-based insurance or public programs such as Medicare, Medical Assistance (Medicaid) and MinnesotaCare.

As of April this year, about 166,000 Minnesotans

have coverage through the individual market.

This year, for the first time, insurers were required to submit two sets of proposed rates: One set with, and one set without, a new state reinsurance program.

Earlier this year, Minnesota enacted a law to create the Minnesota Premium Security Plan. This reinsurance program is designed to help stabilize premiums in the state's individual market, providing a financial backstop against especially high-cost claims.

Implementation of the reinsurance program is contingent on federal approval, which is pending. The state's application for what is known as a 1332 waiver application was submitted by the Commerce Department to the U.S. Department of Health and Human Services.

"To date, we have received positive feedback from federal officials to get their approval for the reinsurance program," said Commerce Commissioner Mike Rothman. "We are still waiting to receive that approval and hope federal authorities decide by the end of August in order to help finalize the lower rates with reinsurance for

Despite uncertainties about potential Congressional action on health reform, the Commerce Department instructed insurers to prepare their rate proposals based on existing federal laws and regulations that currently apply for 2018.

On behalf of Minnesota consumers, the Commerce Department will conduct a rigorous, thorough rate review of each insurer's rate proposal.

Rates must be justified both by the benefits that consumers receive for their premiums and by the insurance company's ability to pay expected medical claims costs based on premium revenue.

Insurers must also comply with state and federal laws that protect consumers, including coverage for pre-existing conditions and free preventive care, the adequacy of the provider network and the procedures an individual must follow to enroll or have a claim paid.

As part of the rate review process, the Commerce Department is accepting public comments on the insurers' 2018 rate proposals through Aug. 31. Minnesotans can submit comments to healthinsurance.ratecomments@state.

Minnesota death tax is out of step with most states

Minnesota is one of 18 states and the District of Columbia that levy either an estate or inheritance tax, often called death taxes. Among these states, a new report by the Tax Foundation shows Minnesota imposes the sixth most burdensome death tax in the country, making Minnesota a real outlier.

Comparing state estate and inheritance taxes is complicated because there are so many variations in how these taxes are levied. To help compare states, the Tax Foundation calculated the effective estate tax rate each state applies to four different values of estates—\$2.5 million, \$5 million, \$10 million and \$20 million. The report also calculated effective inheritance tax rates states apply to bequests of \$100,000, \$500,000 and \$1 million.

The table below combines the Tax Foundation information on both effective estate and inheritance tax rates and ranks states from the highest rate to the lowest rate. As the table shows, Minnesota imposes the sixth highest effective death tax rate in the country for three of the four estate/bequest values and ranks fifth for estates/be-

quests valued at \$5 million. Minnesota's estate tax burden is even more of an outlier when compared regionally. Minnesota and Illinois are the only states that impose an estate tax outside the Northeast and the Northwest coasts. Minnesota is further isolated by the fact that Illinois imposes a tax on estates valued at \$10 million at about half the effective rate as

Minnesota. There are economic con-

ing such an outlier. As the Tax Foundation report explains, "Studies show that economic decision-making is, in fact, affected by inheritance and estate tax regimes." The report then itemizes several economic ramifications, including reduced hiring, business divestiture, less entrepreneurism, less saving, less investment, lower GDP growth, and years of lost tax revenues from wealthy people moving to avoid the

To this last point on people moving, wealthy people are clearly avoiding Minnesota. American Experiment's 2016 report, Minnesotans on the Move, analyzed a new set of IRS migration data. These data irrefutably show Minnesota is losing high income earners. Looking at migration by income level between 2011 and 2014, the second largest net loss of people came from households earning \$200,000 or more. The largest loss came from people earning \$100,000 to \$200,000. With few exceptions, this net of loss people go to lower tax states.

Pull all the evidence together - the economic studies, the economic theory and the migration data - and it becomes clear Minnesota's outlier status on the estate tax impacts the economy. From the perspective of many economists, the economic costs of the estate tax outweigh the modest revenue states collect. And the revenue is modest. In FY 2017, Minnesota's estate tax brought in \$130 million - just 0.6 percent of state revenues.

Many state lawmakers do understand the severe economic costs of Min-

sequences to Minnesota be-nesota's estate tax. This year legislators proposed a number of bills to eliminate or reduce the estate tax. The first tax bill vetoed by Governor Dayton would have raised the estate tax exemption amount to the federal level, which is currently set at \$5.49 million compared to Minnesota's \$1.8 million exemption. As a compromise, lawmakers settled on raising the exemption amount to \$3 million by 2020.

> This is certainly a step in the right direction, but it's only a small step. If other states maintained their current estate taxes, then Minnesota's effective tax rate ranking might improve by four or five spots by 2020. However, several states ranked just below Minnesota are currently phasing in much larger reductions to their estate tax. New Jersey's estate tax will be eliminated next year. Maryland's exemption amount will match the federal amount by 2019 and the District of Columbia's exemption amount is also set to reach the federal amount in 2018, so long as certain revenue conditions

> are met. With New Jersey, Maryland and the District of Columbia all reducing estate taxes by more than Minnesota, Minnesota's effective tax rate will likely only improve relative to Rhode Island (and partially Connecticut) after the exemption amount rises to \$3 million. Thus, Minnesota will undoubtedly remain an outlier without further action to reduce the estate

Provide for cover crops in insurance guide

Farmers manage crops, maintain equipment, and market products, often while balancing a second job and family demands.

Adding a dispute with a crop insurance company is the last thing farmers need.

Kevin Glanz, a farmer near Manchester, Iowa, has planted cover crops for five years. Cover crops are usually grasses or legumes planted between crop rotations to suppress weeds, manage soil erosion, and help soil quality.

Last year, his crop insurance agent raised concerns. After three in-person inspections as part of a quality control audit, Kevin understood if he filed a claim in the fall, his loss may not be covered due to a cover crop practice.

Crop insurance is managed by the federal government, which underwrites policies. In addition, the U.S. Department of Agriculture has established 'Good Farming Practices" to help define good crop management and steward-

However, "Good Farming Practices" does not address cover crops, so there is an additional set of guidelines that direct when farmers should terminate cover crops before planting their main crop to remain eligible for crop insurance.

In 2015, the government spent nearly \$8 billion on administering crop insurance, including support for farmers' crop insurance bills (or premiums), indemnities, and expense reimbursement to crop insurance companies.

Congress is beginning work on the next farm bill, and we urge our elected representatives to consider policies that encourage crop insurance companies

Farmers and good stewards like Kevin need to know they can depend on

to support conservation

practices, such as cover



Back-to-school season is here. It's time for parents to gather school supplies and back packs. It's also the perfect time to make sure children are up to date on their vaccines.

Child care facilities, preschool programs, schools and colleges are prone to outbreaks of infectious diseases. Children in these settings can easily spread illnesses to one another due to poor hand washing, not covering their coughs, and other factors such as interacting in crowded environments.

To celebrate the importance of immunizations for people of all ages, and make sure children are protected with all the vaccines they need as they go back to school, Todd County Health & Human Services is joining with partners nationwide in recognizing August as National Immunization Awareness Month.

Todd County Health & Human Services will be holding immunization clinics on Tuesday, August 1st and Monday, August 28th from 9 a.m.-noon and from 1-4 p.m. There will also be a late afternoon and early evening clinic held on Wednesday, Aug. 30 from 3:30-7:30 p.m.

Getting children all of the vaccines recommended by CDC's immunization schedule is one of the most important things parents can do to protect their children from serious diseases," said Samantha Cofell. "If you haven't done so already, now is the time to check with your child's doctor to find out what vaccines your child needs.'

Vaccines protect against a number of serious and potentially life-threatening diseases.

When children are not vaccinated, they are at increased risk for diseases and can also spread diseases to others in their classrooms and community- including babies who are too young to be fully vaccinated and people with weakened immune systems due to cancer or other health conditions.

Talk to your child's doctor to find out which vaccines are recommended and required for them before going back to school.

Motley Community Garden provides a way to 'give back'

Garden plots available to the public

This is the second summer that Ed Bartle of Cushing has grown vegetables at the community garden in Motley, located next to the food shelf at 697 3rd Ave South.

He's enjoying the process, Bartle said. Plus, it's a way for him to give back to the community.

"I've got five plots," Bartle said recently, mentioning that each plot measures 12' x 18.

He's planted a variety of vegetables, including red and white onions, green beans, potatoes, Indian corn; and Kohlrabi, which has already been harvested.

After experiencing 'crop failure" his first go-around at the garden, Bartle is pleased to see how green and healthy the crops are looking. He's also planted some gladiolus flowers to add color; and a few American flags decorate the corners of his

plots. "I'm a navy veteran," Bartle shared.

This is only the sixth time Bartle has had a garden, so he still considers himself a novice gardener.

"I don't have a green thumb," Bartle went on, shaking his head as to why everything appears to be growing so well. "I usually stop by here every evening to water or weed," he said. The food shelf provides access to water, which Bartle is grateful for.

He gets a lot of advice from his mother. Helen Bartle, who has been an avid gardener for years. "She gives me a lot of tips," he said.

Some of the vegetables he'll keep for himself, but he plans on giving most of what he harvests to the food shelf. "It's a way for me to give back," Ed Bartle said, sharing that when times have been tough in the past, he's utilized the food shelf.

He's found that he really enjoys being outside, working in the garden. "I'd rather be doing this than sitting in a bar, especially since I don't drink anymore," Bartle said.

The Motley Community Garden was started in 2010 by Sharon Stone, the previous director for the Motley Area Food Shelf (MAFS). A total of 14 garden plots are available.

In addition, each spring Cheryl Koll of Motley puts together 'grow kits' that are given to both the Motley and Staples food shelves. These kits contain tomato and pepper plants, onion bulbs and garden seeds. Clients of the food shelves really appreciate getting them, said Sherry Miller Frisk, MAFS direc-





August's arrival begins countdown to hunting

It may be true, as English poet Alfred Lord Tennyson penned, that "In spring a young man's fancy turns to thoughts of love.' But it's similarly true that in August the fancy of many, myself included, turns to thoughts of fall and the arrival of the hunting seasons.

Of course, there are still

plenty of fishing opportunities to be pursued, with the odds of good days ahead actually improving as the day-night balance continues to shift in favor of

the dark hours, and the accompanying temperature swing be-

gins to cool the lakes.

But after all, it's been two-thirds of a year - give or take - since many of us last hunted, and many will agree that for this favorite activity, truly, "absence makes the heart grow fonder." A number of things can trigger this turn of mind, one of the more predictable being the arrival of the fall hunting catalogs. Thankfully, for the oldfashioned like me, they're still printed by several of the mass-merchandisers of outdoor gear and goods.

There have always been long-distance mail order outdoor gear providers, like the venerable L.L. Bean, the original Eddie Bauer and Orvis, and - for a good many years - Herter's, based right here in Minne-

Eventually the success of "big box" local retailers - the Fleet Farms, Targets and the like - became the business model for hunting, fishing and outdoor gear - with firms like Cabela's, Bass Pro Shop or Gander Mountain - and the writing was on the wall for many small, independent brick-and-mortar retailers of such things, though exceptions continue to prove the rule.

These catalogs that accelerate the shift in our thinking began arriving during the last week of July. One might think that the only marketers who benefit from our renewed hunting consciousness are those whose glossy, professionally designed and photographed catalogs arrive in our mailboxes. But there's less retailer loyalty than brand loyalty, and for many of the best products there are multiple places to get them. I might see a great looking hunting coat or chest-high waders in one catalog, and without much effort learn that I can get it from another retailer just a 15-minute drive from home. This retailer didn't pay for the advertising, but might get the sale.

When it comes to hunting gear, some of us have a hard time drawing a bright line between "need" and want." It's easy when poring over alluring catalog pages to find new or superlative virtues in a product that might be little different from one you already own. That's when you begin rehearsing your defense, before the crime of unnecessary purchase has even been committed.

Duck decoys are that kind of weakness for me. I own easily over a hundred, if you count the cruder fakes from earliest purchases. In all honesty, my hunting partner and I seldom set out more than four dozen at one time. But last fall, as the duck season was winding down, I gave in to the persistent voice that since the arrival of the 2016 catalogs had urged me "Go ahead, buy them."

I negotiated an endof-season-fire-sale price for a dozen and a half of the most realistic looking new decoys I have yet to see. Not that the life-like glint in their glass eyes, or beautifully sculpted and painted wing feathers, will be as much appreciated by the ducks as they will by my hunting partner Jim and me. Our best defense is that, with competition from skilled, well-equipped waterfowlers where we hunt, "One can't have too many really good decoys!'

Game Fair will prime your pump

One of the events that since 1982, has signaled the approach of the hunting seasons is Game Fair, a veritable state fair of hunting activities, learning opportunities and - ves window shopping, held in rural Anoka County, between the Twin Cities and Elk River.

Game Fair is held on the grounds of Armstrong Ranch, which - at 80 acres is not a ranch in the Montana or Wyoming sense, but reasonable for semirural Anoka County. The grounds also include the Labrador retriever breeding and training kennels of Chuck and Loral I. Delaney, the latter a member of the Minnesota Trapshooting Hall of Fame.

Game Fair runs for two three-day weekends, August 11-13 and 18-20. Its events include five-stand and "flurry" clay target shooting, instructional shooting seminars, dog training seminars as well as competitions for your hunting dog, duck and goose calling seminars and competitions - contest winners qualifying for the World Championships in Stuttgart, Arkansas - archery shooting range and seminars, various small game, big game, and bird hunting seminars, hunting equipment vendors, even an angling seminar for those who desire a momentary break from the hunting focus. Wildlife art displays, food concessions, special events for children: no doubt I've missed one or more of the many Game Fair events.

An admission fee is charged. More information can be had at gamefair.com. or by calling 763-427-1771.

Shoot now or regrets

later If you're not someone who shoots regularly in a sporting clays, trap or skeet league, nor have from time to time this summer visited a shooting range on an informal basis, the best advice that can be given is 'Hey, it's August; what are

you waiting for?' We may be asking the eternal question "Where has the summer gone," but it's less than four weeks to the start of the first bird hunting season; mourning doves, on Sept. 1. Then early goose season begins Sept. 2, Youth Waterfowl Day is tentatively set for Sept. 9, ruffed grouse and archery deer hunting open Sept. 16. and - still tentative, but likely, based on past years the general duck and goose hunting season will open Sept. 23.

For we hold that one is justified by faith alone apart from works of the law. -Romans 3:28 Pastor Robin Collins, Trinity Lutheran Church, Staples

"Sola" the Latin word meaning: ALONE; and it was a touchstone Word for the Reformation. The key idea, seen in the verse above, is that a person is justified before God, declared righteous by God, through faith ALONE - you can contribute nothing because you cannot keep God's Law perfectly.

But "Faith Alone" - "Sola Fides" - is not the only "Sola" of the Reformation. There are in fact five (5) "Solas" which are interdepent and interrelated. They are:

Grace Alone, Scripture Alone, Christ Alone, to the Glory of God Alone.

The way they all fit together is like this.

You are justified before God by faith. But you cannot generate faith on your own. It must be given to you, a gift. That's GRACE - a gift,

something that you do not, cannot earn no matter how hard you might try. God's GRACE and thus FAITH, is given to you by God through His Word. God doesn't just zap you with faith out of the blue; rather it comes through hearing God's Word. (Romans 10:17). And this FAITH, given by God's GRACE, through the hearing of His WORD, is in CHRIST ALONE. For Christ is the ONLY WAY to the Father (John 14:6); He has finished all that was needed to redeem you from sin and death (John 19:30).

This all is to God's glory because God ALONE HAS done everything necessary for your salvation; winning it for you and giving it to you by His grace, through faith, by His Word, in Christ, ALONE.

To God be the glory. Amen.
